PRESENTATION OF THE WARRANT

Warrant no. 2024-04 was made available for the Commission's inspection.

APPROVAL OF THE AGENDA

Hearing no proposed additions, Mrs. Goff declared the agenda approved as printed.

APPROVAL OF THE MINUTES OF JULY 10, 2023

By a motion made and seconded, the Commission voted in a roll call vote five in favor, none opposed and Mr. Mott and Mrs. Reimann abstaining to approve the minutes as written.

NEW BUSINESS

1. Agency Land Management: Purchase of Equipment

The Commission reviewed bids received for the purchase of a new truck to replace its 2012 F350 pickup truck, listed here in descending order by price: (1.) MHQ, \$69,627 (2023 model); (2.) Empire Ford, \$63,120 (2022 model); and (3.) Colonial Ford, \$59,980 (2022 model). Mr. Kisiel recommended Colonial Ford, as low bidder and because its truck, although not a 2023 model, has fewer than 100 miles on it.

\$65,000 was budgeted for this purpose. After discussion and by a motion made and seconded, the Commission voted unanimously to accept the low bid and, should that particular vehicle prove no longer available, to cascade down to the next lowest bid. Should the second vehicle prove unavailable the land bank will issue a fresh invitation-for-bids.

2. Agency Land Management: Disposal of Equipment

Mr. Kisiel reported that a single bid was received for the land bank's 2007 GMC 2500 pickup truck, declared surplus by the Commission at its June 26, 2023 meeting: (1.) Donovan Biersteker, \$100. Mr. Biersteker is a land bank summer ranger.

Mr. Kisiel pronounced the vehicle "literally worth almost nothing" and stated that it may possibly be suitable only for "parting up." He believes that extending the bid timetable, especially if conjoined with off-island advertising, would be prudent. Mrs. Reimann noted that a junkyard may make an offer.

After discussion and by a motion made and seconded, the Commission voted unanimously to proceed to seek additional bids. Mr. Kisiel will advertise off-island if he determines that doing so would be worth the expense.

3. Quenomica Preserve (Town of Edgartown)

The Commission reviewed bids received for re-roofing the cottage here (including replacing the roofline trim and the wooden gutter), listed here in descending order by price: (1.) Bel Islands Home Improvement LLC, \$38,670; (2.) Paul and Paul Services, \$31,244.96; and (3.) Eventide Construction, \$29,450. Mr. Kisiel recommended Eventide Construction, as low bidder.

\$35,000 was budgeted for this purpose. After discussion and by a motion made and seconded, the Commission voted unanimously to accept the staff

recommendation. Mr. Kisiel stated that he would have analyzed the project for solar suitability had he been certain that the cottage itself had a secure long-term future.
